## 7/8 Camp 2017 – Berry Sport and Recreation

Dear Parents/Carers and Students,

We are currently planning a Year 7/8 camp for Term 3, 2017 to Berry for a coastal experience. Students will have the opportunity to choose between water or land based activities, depending on their swimming confidence. ### Details of camp:

**Where:** Berry Sport and Recreation, Berry, NSW

**When:** Monday 28 August – Wednesday 30 August 2017

**Cost:** The approximate cost for the camp is \$330. This price may vary slightly depending on the numbers interested. This price includes bus, accommodation, meals and programmed activities. If we have sufficient interest we will explore some fund raising options to try and minimise this cost.

To ensure this camp is a viable option, please fill out the Expression of Interest form attached and return to school no later than **Wednesday 5 April, 2017 (Week 10)**. We will make a decision whether or not to go ahead with the camp based on the information returned.

**A deposit of \$50 will be required to reserve your child's spot on camp. There are limited places available on camp and students who return their Expression of Interest note AND deposit will be given preference.** Please do not hesitate to contact Mr. Jason Holmes if you require financial support.

Places are allocated by the order of permission notes returned and payment of money. A waiting list in order of permission notes returned will be used if places become available. **If students withdraw from the camp a refund cannot be guaranteed unless a suitable fully paid waiting list student can be found to take their place.**

It is customary for the school to request a financial contribution towards meeting the cost of your child's participation in this camp/excursion. The school has made every effort to keep costs for this activity at a reasonable level. This is an enrichment activity so a payment will be required to cover all costs. The school reserves the right to cancel the activity should all costs not be covered. Individual records of contributions are confidential.
