

**Early Learning STEM Australia (ELSA)****Consent form – 2019 ELSA Pilot**

Dear Parent / Legal guardian,

Your child's preschool service has been selected to take part in the 2019 ELSA Pilot.

The ELSA Pilot is a play-based digital learning program for children in preschool to explore science, technology, engineering and mathematics (STEM) practices and concepts.

ELSA has been developed by the University of Canberra through funding provided by the Australian Government Department of Education and Training under the National Innovation and Science Agenda. Professor Tom Lowrie from the University of Canberra will lead the pilot, which is delivered via hands-on activities and educational apps on tablets. The apps encourage children to ask questions, make predictions, experiment, and reflect on what happened and why. They also encourage active play that supports creativity and problem solving. Each child will participate in a maximum of 40 minutes screen time per week (broken up into smaller sessions).

As ELSA is a pilot, the Department of Education and Training has engaged the Australian Council for Educational Research to undertake an evaluation of the design and implementation of ELSA during 2019.

In order for your child to participate in the 2019 ELSA Pilot, we need your consent. You can choose the level of involvement your child will have in the pilot by completing the two parts below.

The ELSA team values your child's privacy. Below we have outlined how your child's personal information will be collected, stored and used.

Privacy: How the 2019 ELSA Pilot will collect, store and use data

- Your personal information is protected by law, including the *Privacy Act 1988*, and is collected by the University of Canberra for the purpose of running the ELSA Pilot.
- The University of Canberra will collect and use the personal information of children and parents/legal guardians for the specific use of the ELSA Pilot only. The personal information collected will include your child's name and date of birth, as well as your name and signature.
- All data collected as part of the pilot will be:
 - stored on secure servers in Australia, with a unique number assigned to each child (no personal information is being sent overseas); and
 - de-identified (removing names of children) before being used in reports or published in academic papers.
- Data and personal information may be used and disclosed by the University of Canberra to the Department of Education and Training, the Australian Council for Educational Research,

Consent from parents / legal guardians

(Note: ELSA apps are designed for children in the year before formal schooling – generally those aged four or five in 2019).

If your child is **4 or 5** in 2019, go to **Part 1a**. Otherwise, go to **Part 1b**.

Part 1a – Participation (for children aged 4 or 5 in 2019)

Choose ONE of the options below by ticking the appropriate box:

- I give consent for my child to fully participate in the 2019 ELSA Pilot. This includes my child using the ELSA apps, and my child's usage data being recorded for research and evaluation.
- I give consent for my child to use the ELSA apps, but request that no usage data be recorded.
- I do not wish my child to use the ELSA apps, but give my consent for my child to participate in the off-app ELSA activities.

Part 1b – Participation (for children NOT aged 4 or 5 in 2019)

Choose ONE of the options below by ticking the appropriate box:
