Dear Parents and Carers,

Harrison School is excited to offer all Year 2 students the opportunity to participate in the ACT Water Safety Program delivered through Royal Life Saving ACT. This program provides students with essential swimming, water safety, survival, rescue and lifesaving skills. Participation in this program is an ACT Education Directorate requirement for all Year 2 students.

The ACT Water Safety Program is a 5-day intensive program for Year 2 students, teaching swimming, survival, rescue and lifesaving skills. The program follows the nationally recognised Royal Life Saving Swim and Survive Curriculum, which is closely aligned with the National Swimming and Water Safety Framework.

The program includes practical pool sessions as well as classroom learning modules provided to schools to complement students' learning and understanding of water safety concepts.

These lessons will be delivered over a one-week program, with students participating in one 1-hour session each day at Gungahlin Leisure centre.

Year 2 ACT Water Safety Program

Lesson Overview



The ACT Water Safety Program is a 5-day intensive program for Year 2 students, teaching swimming, survival, rescue, and lifesaving skills. It follows the nationally recognised Royal Life Saving Swim and Survive Curriculum which is closely aligned with the National Swimming and Water Safety Framework.

All schools have been provided with classroom learning modules, designed to complement the practical sessions at the pool.

Teachers will provide parents and carers with the links to enrol students into beginner, intermediate, or advanced levels based on their swimming ability.

● BEGINNER

Students in this level will work towards Swim and Survive Level 3

Level 3 includes slide entries, floating on the front & back, treading water for 30 secs, swimming 10m freestyle, 5m backstroke, learning the survival strokes, submerging in chest-deep water, and simple survival sequences.

● ADVANCED

Students in this level will work towards Swim and Survive Level 7

Level 7 includes stride and dive entries, sculling, floating and treading water for 2 minutes while signalling for help, swimming 75m freestyle, 50m backstroke and breaststroke, searching for objects in deep water, throw rescues, and

● INTERMEDIATE

Students in this level will work towards Swim and Survive Level 5

Level 5 includes step entries, sculling, floating and treading water for 1 minute, swimming 25m freestyle, 25m backstroke, 15m breaststroke, 15m survival strokes, practicing reach rescues, and survival sequences with buoyant aids.

Final Day Activity

All students will take part in a supervised water safety scenario using an inflatable boat while wearing clothes in the pool.

Suggested clothing: long pants and a long-sleeved top, pyjamas, or other old clothing suitable to be worn in the pool.
